Do they need a ride to get their vaccine shot? Are they staying warm? Maybe just a conversation would help make their day? They are not forgotten.

Bylaws WHY?

Bylaws are the rules and principles that define your governing structure. They serve as your nonprofit's architectural framework. Although bylaws aren't required to be public documents, consider making them available to the public to boost your nonprofit's accountability and transparency.

Your bylaws might cover such topics as the:

- Broad charitable purpose of the organization.
- Size and function of your board.
- Election, terms and duties of directors and officers.
- Basic rules for voting, holding meetings, electing directors, and appointing officers.

Without being too specific, your nonprofit's bylaws also should provide procedures for resolving internal disputes, such as the removal and replacement of a board member. If you are not familiar with your organization's bylaws, you should get up to speed quickly.
